5.2. In the full range, by signed registered letter or by electronic form within the particular section of ITAPA web. Based on this, all the personal data of „the person „who is registering to attend ITAPA event“, will be deleted under the particular assignments § 30 Abridgment of the rights of the data subject and § 28 The rights of the data subject, based on the Act on Personal Data Protection

I am aware that providing of my personal data is necessary for

5.4.following notification about the prepared events, information about the news in the sector and marketing information and information about the provider's activities, in the case of the abrogation of the consent, this service will not be provided

- 7. Legal basis for the personal data processing are particular laws of the Slovak Republic (concerning business relationships of the participation at the events) or the consent of the data subject.**
- 8. Period of validity of consent to personal data processing is 10 years plus time, specified by the Act. 395/2002 Coll. about the archives and filling cabinets and about the addition of some laws.**
- 9. As the data subject, I am giving the consent for the accessing and providing personal data from the information system of the provider to the third parties, including the subjects in the member states of EU within the cross-border transfer, exclusively for the personal data processing under following all the assessments of the Act on Personal Data Protection.**

A.3. the correction or the cancellation my incorrect, incomplete or outdated personal data that have been processed

A.4. Disposal of the personal data

A.5. blocking of my personal data in the case of the abrogation of the consent before its validity expiration, if provider has been processing personal data based on the consent of the data subject

B. Based on the written application, I can object to

B.1. processing of my personal data, if I suspect that my personal data are or will be processed for the direct marketing purpose without my consent and and I can apply for their disposal

B.2. using personal data, allocated in § 10 Article 3 Letter d) Act on Personal Data Protection for the purpose of direct marketing by post or
