# **CONSENT to the Processing of Personal Data**

# 1. Scope of provided personal data processed by the operator:

- 1.2. contact details (company / editorial office /, address, ID number, VAT number, VAT ID number, e-mail address, telephone number)
- 1.3. additional data (registered as: participant private sector, participant public administration, visitor student, participant webstream online transmission, lecturer, journalist accreditation, classification, days of participation, Facebook name, newsletter subscription, marketing information subscription, payment of registration fee , if the lecturer name and place of deposit of the contribution, suggestions from the registered, feedback of the operator to the suggestions)
- 2. **The operator may provide** personal data to the intermediary if there is a contractual relationship between the operator and the intermediary that meets all the requirements of the Personal Data Protection Act.



#### 3. Scope of provided personal data processed by the intermediary:

- 3.1 identification data (name, surname, title, nationality)
- 3.2 contact details (company, address, ID number, VAT number, VAT ID number)
- 3.3 additional data (registered as: participant private sector, participant public administration, visitor student, participant webstream online transmission, lecturer, journalist accreditation, days of participation)

## 4. Personal data are provided for the purpose

- 4.1. operator:
  - 4.1.1.preparation and implementation of events / presentations
  - 4.1.2.information on news in the sector (newsletter, ...), if the person concerned has given special consent for this purpose
  - 4.1.3.provision of marketing information if the person concerned has given his specific consent for this purpose
  - 4.1.4.closing contractual relationships
  - 4.1.5.registration of suggestions of lecturers, participants, visitors for the purpose of increasing the quality of provided services, operator's feedback on suggestions
  - 4.1.6.processing of attendance documents (will be used only within the scope of personal data protection: name, surname, company, signature)
  - 4.1.7.presentation of contributions and information about organized events in the means of mass communication (will be used only for personal data protection) in the range: name, surname, position, company, manager, lecturer, title of the event, while the lecturer may decide to publish his email or tel. number), in particular:
    - a) posting of lecturer contributions on the web (in pdf format)
    - b) posting information about the planned / implemented event (managers, lecturer) on the web
    - c) processing / provision of press release documents
    - d) publishing streaming video with the sound of the presenter
    - e) publishing photos and short videos of the planned / realized event, capturing the participants
- 4.2.intermediary:
  - 4.2.1.accounting and related financial operations

#### 5. I can revoke the consent as the person concerned

- 5.1. **to a partial extent**, in the corresponding part of the ITAPA portal website after clicking on the message that was delivered, on:
  - 5.1.1. subscribing to news in the sector (newsletter, ...)
  - 5.1.2. subscribing of marketing information
- 5.2. but also **in full,** signed by registered letter or electronically in the corresponding part of the website. As a result, all personal data of the relevant person concerned will be deleted, in compliance with the relevant provisions of Section 23 of the Personal Data Protection Act.

However, I am aware that the provision of my personal data is essential for

5.3. entering into a business relationship on participation in the event and for the administration and subsequent control of this relationship,



- 5.4. subsequent notification of upcoming events, information on news in the sector and marketing information and information on the activities of the operator; if the consent is revoked in full, this service will not be provided,
- 5.5. feedback on any suggestions I have provided
- 6. **I agree** that, if necessary, additional personal data necessary to fulfill the purpose of the processing be added to the personal data already provided.
- 7. **The legal basis** for the processing of personal data is the relevant laws of the Slovak Republic (concerning the business relations of participation in events) or the express consent of the person concerned.
- 8. The period of validity of the consent to the processing of personal data is 10 years plus the time defined by Act No. 395/2002 Coll. on archives and registries and on the amendment of certain laws as amended.
- 9. At the same time, as the person concerned, I give my consent to access and provision of personal data from the Operator's information system to third parties, including entities in the Member States of the European Union in cross-border transfers, solely in relation to the purpose of personal data processing, in compliance with all respondent provisions of the Personal Data Protection Act.

At the same time, I declare that, as the person concerned, I am aware of my rights in accordance with the provisions of § 21 Personal Data Protection Act, in particular:

- A. I have the right, upon written request, to request the operator
  - A.1. confirmation of whether or not personal data about me are being processed
  - A.2. in a generally comprehensible form
    - A.2.1. information on the processing of personal data in the information system
    - A.2.2. information about the source from which he obtained my personal data for processing
    - A.2.3. a list of my personal data that is the subject processing
  - A.3. correction or destruction of my incorrect, incomplete or out-of-date personal data which are the subject of processing
  - A.4. destruction of personal data
    - A.4.1. whose processing purpose has ended
    - A.4.2. which are the subject of processing if there has been a breach of the law
  - A.5. Blocking of my personal data due to the revocation of the consent before its expiration, if the operator processes personal data with the consent of the data subject
- B. I have the right, upon written request, to object to the operator
  - B.1.processing of my personal data which I assume are or will be processed for direct marketing purposes without my consent and request their destruction
  - B.2.use of personal data specified in § 27 paragraph 2 of the Personal Data Protection Act for the purposes of direct marketing in the postal system or for the purposes of direct marketing.



C. If I suspect that my personal data is being processed unjustifiably, I may submit a request to the Office for Personal Data Protection to initiate proceedings on personal data protection.

By filling in the web form with the data, checking the box for consent to the processing of personal data and selecting the option "Submit" when electronically registering on the ITAPA website, I confirm to the Operator that I agree to the processing of personal data, that I understand the content of this document and that the data I have provided are true.
